

- 3. Participation in joint funded research projects and public sector units, participation of joint consultancy, promote and support innovative projects undertaken by students and staff of both parties.
- 4. SMVCE commits to make available the students, professors, training rooms and required hardware resources during the program as may be required.
- 5. VKG Bajaj, Yadagiri may be given the opportunity to the qualified management students to attend campus interviews however subjected to the recruitment plan/policy of the company.
- 6. In order to assess the impact of the program on the student's career, company requires details about the student's after graduation in terms of placement and higher-education. The college management agrees to provide this data and all support required to capture this information to company.
